**Dragon-Ukrainian Properties & Development plc (the "Company")**

**Director Shareholding**

The Company received notification on 10 August 2017 from Dragon Capital (which together with the Company's Investment Manager DCM Limited is a part of the Dragon Capital Group) that on 9 August 2017 Dragon Capital purchased 333,367 ordinary shares at a price of £0.15 per ordinary share. The transaction took place in Kyiv, Ukraine.

Following this share purchase, Dragon Capital Group now holds 66,607,334 ordinary shares representing 60.91% of the issued share capital of the Company.

Tomas Fiala, one of the Company's directors, is the principal shareholder and managing director of Dragon Capital.

The notification is required under Article 19 of the Regulation (EU) No 596/2014 as the Dragon Capital Group is a person closely associated with Tomas Fiala.
